

## **Supplemental Terms and Conditions for Talent Management version b1305:**

These Supplemental Terms and Conditions for Talent Management version b1305 (“**Supplemental Terms**”) apply to and amend the Software License and Maintenance Agreement or equivalent agreement (“**Agreement**”) of SuccessFactors, Inc. (“SuccessFactors”), as successor in interest to Plateau Systems, Ltd. Any terms not defined in the Supplemental Terms will have the meaning set forth in the Agreement.

**1. Third-Party Components and Licenses.** The Software contains certain open source and third-party software components, including without limitation, the components listed in the Talent Management b1305 Third Party Software Notice File (collectively, “**Third-Party Components**”). Each Third-Party Component is licensed either under the terms of the Agreement, or if specified in the program documentation, under the Third-Party Component’s applicable license agreement (“**Third-Party License**”). Nothing in the Agreement is intended to modify the user’s rights or obligations with respect to any Third-Party Component set forth in the applicable Third Party License.

**2. No Offer by Third Party Authors, Developers, or Contributors.** To the extent that the Agreement contains any warranty, support, indemnity or liability terms or any other terms and conditions not included in the applicable Third-Party License, these terms and conditions are not offered by or made on behalf of any third party author, developer, or contributor of the applicable Third-Party Components.

**3. DISCLAIMER OF WARRANTIES AND LIABILITY.** EXCEPT AS SET FORTH IN THE APPLICABLE THIRD-PARTY LICENSE AND AS EXPRESSLY SET FORTH IN THE AGREEMENT:
